

Responsible Lawyering meets 10/3 through 11/13/25. Registering

To load your cart and register, you will need to sign in to https://one.iu.edu with your IU credentials and Duo authentication. Follow the video instructions in this video to learn the process to add classes to your shopping cart and to enroll. If you prefer written instructions for each step, you will find them here.

When you are ready to register, use the search bar at the top of one.iu.edu with the search term "cart" to find the Enrollment Shopping Cart tile and select it. The tile looks like this:

• Before you attempt to register, please check for holds on your record that may prevent registration by following this link. If there is a hold, the reason, the department that issued it,

and who to contact will be displayed. Holds typically clear 24 hours *after* taking corrective action. **An immunization hold will not prevent registration**. However, you are still required to comply with <u>IU immunization policy</u> and state law. The link in the previous sentence provides very helpful information on immunization compliance. You'll need to log into <u>Med+Proctor</u> with your IU user ID and password to submit your records. If you have any immunization-specific questions or experience technical issues with Med+Proctor, please reach out to this address for assistance: indyimm@iu.edu.

- LAW-528 Legal Research displays as 1 credit in the McKinney Course List because the system is not able to display 0.5 credits. When you register in Student Center, you will see that the course is 0.5 credits. The same is true for LAW-700 Responsible Lawyering.
- The McKinney <u>Class Schedule</u> and <u>Course List</u> (same information, different views: calendar and course catalog, respectively) are the authoritative source for room locations. Room locations in Student Center (the registration system) may not be correct. *Please double-check room assignments the day before classes begin* as changes may have occurred. Maps of each floor are located near the North elevators.




