Minimum Grade Requirements

- Minimum grade requirements in foundational courses:
 - D+ or lower in Civil Procedure, Constitutional Law, Contracts, Criminal Law, LCA II,
 Property, or Torts must repeat the course
 - . C- or higher in LCA I before can take LCA II
 - Fee remission for retaking course unless the grade was received due to academic misconduct
- After First 1L Semester: Cumulative GPA Under 2.5 Academic Warning
 - Required to meet with Erin Engels, Director of Academic and Bar Success (ABS)
 - Develop and implement an academic achievement plan
 - Failure to meet = inability to register for further courses
 - May not enroll in summer courses without ABS approval

Minimum Grade Requirements

- After First Two Semesters or Any Subsequent Semesters
 - Cum. GPA Between 2.30 and 2.50 Academic Warning
 - · Required to meet with Director of ABS
 - Develop and implement an academic achievement plan
 - Failure to meet = inability to register for further courses
 - Cum. GPA Between 2.00 and 2.30 Academic Probation
 - 20 credit hours to achieve cum. GPA of at least 2.30
 - Remain on academic probation for full 20 credit hours, even in cum. GPA of 2.30 achieved prior to that time
 - Director of ABS, individually or in consultation with OSA AD, any Vice Dean, or any faculty member may impose or recommend any educationally reasonable conditions on the student
 - Failure to fulfill = dismissal, required to withdraw, or required to take LOA
 - Failure to maintain semester GPA of 2.30 or cum. GPA of 2.30 = dismissal

Minimum Grade Requirements

- · After First Two Semesters or Any Subsequent Semesters
 - Cum. GPA under 2.00 Dismissal
- · Restriction on Readmission
 - Students academically dismissed will not be readmitted
 - Dismissed student may apply as a new student in the third or later academic year following dismissal
 - Upon showing of good cause to law school admissions committee may apply as a new student in second academic year following dismissal
- ABS has many resources to help take advantage of their programming and services!



Academic Accommodations for Students with Documented Disabilities and Title IX Accommodations for Pregnant Students

- All requests for classroom and/or testing accommodations under the ADA must be evaluated by the IU Indianapolis disability services office, <u>Accessible Educational Services</u> (AES)
 - Request accommodations and upload medical documentation online
 - Once request is submitted, you will be contacted by AES staff to complete an intake meeting with an accessibility specialist
 - Approved students are issued a Letter of Accommodation (LOA)
 - LOA will specify the accommodation for which you are approved

Testing Accommodations

- Not available for take-home exams lasting 24 hours or more, papers, or oral presentations
- · Implemented by professor email professor LOA
 - Timed and graded quizzes
 - · Graded midterms in elective courses
 - Canvas exams
- Implemented by OSA email <u>laccom@iu.edu</u> LOA
 - · In-person, timed and graded 1L midterms
 - In-person proctored exams

Final Exam Policy and Schedule

- Final Exam Schedule
- Exams taken at scheduled time unless a reschedule is approved
- Rescheduling exams requires ADSA approval faculty cannot approve
 - Two or more exams on the same day, or two or more in-person exams scheduled within less than 18 hours of each other;
 - Exams scheduled on four or more consecutive calendar days;
 - Serious illness or "other circumstances" beyond your control affecting ability to take exam at the scheduled time
 - "Other circumstances" include things like death of an immediate family member, car accidents, birth of a child, or conflict with employment requirement that cannot be rescheduled or avoided
 - Documented verification required

OSA will email the deadline and form to request a reschedule
